

As Heather Ridge Golf Course moves towards our next phase of providing a healthy and safe environment for our staff and customers, we will be following the below guidelines effective Thursday, October 1, 2020.

Any deviation from the mandatory restrictions listed below will result in terminating your round and the removal from the golf course without any refund. Heather Ridge Golf Course is dedicated to continuing to follow the strict provisions set forth by our governing agencies to keep our customers and staff safe during the COVID-19 pandemic.

Please be advised of the following **MANDATORY** restrictions:

- 6-foot social distancing **MUST** always be maintained while visiting our facility. We will have Marshals and security on the course to enforce this distancing rule and the mandatory restrictions set forth below.
- Golf Carts will be available for single rider or double riders amongst the same party.
- Each golfer must have their own bag and equipment and may not be shared.
- You may be paired with other golfers to fill out the foursome. You will be able to maintain a physical distance of at least 6-feet during your round.
- Golf Carts will be cleaned and disinfected after each use.
- **Golf Carts will only be available for an 18-hole round @ \$20/cart. (Rainchecks will not be available).**
- **Golf Carts will have a mandatory curfew each day. Failure to return carts by the daily curfew may result in forfeiture of further use.**
- **No golf cart will be available for 9 holes-9 holes will be walking only.**
- **Due to the limited number of golf carts, there may not be a golf cart available for your tee time. (Be prepared to walk if no carts are available).**
- Golf Carts will be assigned no earlier than 10 minutes prior to your tee time.
- After your round, golf carts **MUST** be returned to the cleaning area immediately. All trash must be removed and disposed of in the trash bins provided in the cleaning area.
- Push carts and rental clubs will not be available.
- **Carts will not be available to rent after 4:00 pm.**
- **The Driving Range is open with the following restrictions:**
 - **Irons only**
 - **One person per bay at all times-Social Distancing required**

- **The Putting Green is open with the following restrictions:**
 - Available to golfers 10 minutes prior to tee time
 - Chipping in designated area only
- **Face coverings while entering the Pro Shop are required.**
- Flagsticks will remain in the cups with the cup raised to retrieve your golf ball without touching the flagstick. Flagsticks will not be allowed to be removed or touched during your round.
- **No walk along guests will be allowed with any groups on the golf course. Maximum grouping will be 4 golfers. NO EXCEPTIONS!**
- Tee times can be made by calling the Pro Shop at 303-755-3550 (option 1) or from our website at www.golfclubatheatherridge.com
- Calling the Pro Shop at 303-755-3550 (option 1) the day of your tee-time to pre-pay if desired.
- Credit Card payment is preferred.
- Scorecards and pencils will be available on the first tee box.
- There will be no congregating anywhere on our premises, including the parking lot.
- Water Coolers have been removed from the golf course and Pro Shop.
- All restrooms will be disinfected and treated with extreme precaution regarding cleanliness. In addition, we are providing sanitation wipes for our customers entrance and exit of our facility.
- Twilight will begin at 3:00 pm daily. Rates will be \$15 to walk.
- The golfer is responsible for injury or damage that results from the golfer's actions on the golf course. HRMD#1, G.C. at Heather Ridge does not provide insurance for any damage to persons, vehicles, or homes that a golfer may cause while playing golf or otherwise using these facilities.

As we continue to make every effort to remain open and provide a safe and healthy environment for our customers to play golf, we must follow the mandatory restrictions set forth above. We ask that all our customers and staff stay home if you are not feeling well.
